4. **Manager's Report** – Steve Letavic
Woodcrest Drive Water Drainage Issue: Mr. Letavic updated the BOS on the water drainage issue at Woodcrest Drive. Specifically, Mr. Detweiler of 4411 Woodcrest Dr. has complained that his neighbors are causing a water issue on his property because they installed pipes in the Township swale that are collecting and conveying water onto his property. Alan Detweiler 4411 Woodcrest Dr., Ken Freed 4418 Woodcrest Dr. and Jason Musser 4414 Woodcrest Dr. addressed the BOS on this issue. The BOS directed Mr. Letavic to gather more information before any decision is made.

PEMA Update: Mr. Letavic informed the BOS that we will be proceeding with the bidding of demolition on the 4 homes along Swatara Creek in the next month.

LCTCB: Mr. Letavic updated the BOS on a meeting with Lancaster County Tax Collection Bureau's Executive Director John Jabour regarding the collection of Earned Income Tax and Local Services Tax. Staff will be preparing a comprehensive list of businesses to ensure fair tax collection in the township.
