Manager's Report – Steve Letavic

1. TMI: Ralph Disantos : Ralph Disantos and Bill Noll provided an update on activities at Three Mile Island including the replacement of their security providers and re-licensing issues.
2. HIA Noise Buffer Buyout: The FAA noise buffer buyout program was reviewed.
3. Parks Stream Restoration Update: Township manager provided an update on the pending grant for stream bank restoration in Sunset Park.
4. NRC Meeting February 28th: The board was informed of an upcoming re-licensing meeting with the NRC. The meeting will be at the Township Building beginning at 2pm and will cover aspects of the re-licensing process.
5. HR Training Update-February 27th, 9am-11am: The township manager announced mandatory training for Township staff on human resources policy from 9am -11am on February 27th for staff and from 9am - 12pm on February 27th for managers.
6. Colebrook Road Storm Water Update: The manager informed the board that the project will be completed in the spring and that a retainage is being held for punch list items. The board asked the manager and public works director to follow up with residents to see how the system is performing.

7. Zoning Hearing Board Member Replacement: The manager informed the board that we are seeking applicants for the zoning hearing board. The board advised the manager to advertise for the position.
8. Farm Ordinance: The board of supervisors discussed many options related to the ordinance. Supervisor Kopp will report back to the board relative to the farms that appear to fit into the ordinance parameters. The board of supervisors will then provide direction to the planning commission who is tasked with developing this ordinance.
9. Bridge Inspection- PA DOT: The township manager informed the board that PA DOT and PSP will be conducting bridge inspections on Turnpike bridges.
