

**TOWNSHIP OF LONDONDERRY, DAUPHIN COUNTY
PUBLIC NOTICE**

The Board of Supervisors of the Township of Londonderry, Dauphin County, Pennsylvania will hold a public meeting on Monday, March 2nd, 2026, at 7:00 p.m. at the Londonderry Township Municipal Building, 783 South Geyers Church Road, Middletown, PA 17057, at which the Board of Supervisors will consider the enactment of a proposed ordinance that amends the Londonderry Township Code of Ordinances. The title and a summary of the proposed ordinance are as follows:

Ordinance 2026-02

AN ORDINANCE OF THE TOWNSHIP OF LONDONDERRY, DAUPHIN COUNTY, PENNSYLVANIA, AMENDING CHAPTER 1, ADMINISTRATION AND GOVERNMENT, PART 4, PARK AND RECREATION BOARD TO REPEAL THE SAME; CHAPTER 15, MOTOR VEHICLES AND TRAFFIC, PART 6, SNOW AND ICE EMERGENCY TO DESIGNATE OFFICIALS TO DECLARE AN EMERGENCY; AND CHAPTER 16, PARKS AND RECREATION, PART 1, RULES AND REGULATIONS, TO ALLOW THE BOARD OF SUPERVISORS TO PROMULGATE RULES AND REGULATIONS BY RESOLUTION.

Section 1 amends Chapter 1, Administration and Government, Part 4, Park and Recreation Board, by repealing the same in its entirety. Section 2 amends Chapter 15, Motor Vehicles and Traffic, Part 6, Snow and Ice Emergency, to designate the Township officials authorized to declare an emergency. Section 3 amends Chapter 16, Parks and Recreation, Part 1, Rules and Regulations, to permit the Board of Supervisors to adopt rules and regulations for the use of Township parks by resolution; repeals existing rules in the Ordinance; and modifies the enforcement and penalties provisions consistent with the amendments. Section 4 limits the revisions to those stated; Section 5 allows for the severability in the event of invalidity; and Section 6 provides for the enactment of the Ordinance.

The full text of the proposed amendatory ordinance and the revised zoning map are on file for inspection and review without charge (or a copy may be obtained for a charge not greater than the cost thereof) at the Londonderry Township Municipal Building, 783 South Geyers Church Road, Middletown, PA 17057.
