#### OLSDS (On-Lot Sewage Disposal System)

The Township's OLSDS (On-Lot Sewage Disposal System) pumping and reporting management program was initiated in 2014 and established districts that requires all properties within each of those districts to have their septic system pumped and inspected once every four years.

Every septic system in the Township and every treatment tank or cesspool associated with every OLSDS shall be pumped and inspected once every four (4) years by a certified pumper/hauler within a specific time frame.

The Township established five (5) pumping districts identified as Sewer Districts 1, 2 and 3 and On-Lot Management Districts A and B. As a reminder the following pumping/inspection schedule is shown below:

### Emergency Services

#### **Portable Generator Safety Tips**

Take precautions for your safety and the safety of those working to restore your power

#### **ALWAYS**

- Read and follow all manufacturer's operating instructions
- Use your generator outdoors, away from open windows, vents or doors
- Allow the generator engine to cool at least 2 minutes before refueling
- Store the recommended type of fuel for the generator in an approved, properly labeled safety can
- Maintain your generator according to the manufacturer's schedule
- Have a battery-operated carbon monoxide alarm to check for deadly buildup
- Turn off the generator and let it

- cool before refueling to prevent a fire
- Start or stop the generator ONLY when no electrical loads are connected
- Allow at least 4 feet of clearance on all sides of the generator when it is operating
- Keep children away from generator at all times

#### **NEVER**

- Never use a generator inside your home, garage, basement, crawl space or enclosed area, even with ventilation, as carbon monoxide buildup can kill
- Never operate the generator near combustible materials



- Never plug your generator directly into your home outlet as this presents an electrocution risk to utility workers and neighbors served by the same utility transformer - have a qualified electrician install a power transfer switch instead
- Never operate a generator under wet conditions or touch it with wet hands (put it on a level, dry surface under an open, canopy-like structure)
- Never overload the generator or connected appliances and components can be damaged
- Never cut corners when it comes to safety

#### **Tax Collector Notes**

Summer is fast waning, seems like it is forever coming, then is gone before we know it!

You should have received your School Real Estate and your School Personal bills by now. If you haven't received them please call me.

Every adult in Lower Dauphin School District receives a Personal Occupation/Per Capita bill. There are 3 taxes on the bill, a \$250.00 Occupation Tax, a \$10.00 Per Capita Tax, and a \$5.00 Township Tax. There are exemptions for the OCCUPATION TAX only! You may fill out an exemption form for the occupation tax if you are over 70 on July 1st; if you are a full time college student this fall and next spring; if your earnings for the calendar year are under \$6,000.00 (social security, retirement or disability payments are not included in calculating the earnings); or if you are in full time ministry with no other source of income.

To file an exemption pick up a "Occupation Tax Exemption Form". I have them in my office. There is a box outside my door that you can access anytime, or download one from Lower Dauphins website <a href="LDSD.Org">LDSD.Org</a>. If you were only billed the Per Cap and Township Tax [\$15.00] you do not need to file an exemption, the Occupation Tax has already been exonerated.

Again the exemption is for the Occupation Tax only. There is no exemption for the \$15.00!

#### DEPUTY TAX COLLECTOR

I now have a deputy tax collector. She is a township resident and is very capable to sit in if I cannot be in and can handle your tax payments or answer your questions. Her name is Erika Zinkan. Stop in and say hi to Erika!

In order to take advantage of the 2% discount your payment must be in my office or postmarked by August 31st. There is now an option to pay the School Real Estate tax in 3 installments. You lose the 2% discount but do not incur any penalties as long as each payment is made on time. The first payment is due by August 31st, the second is due by October 31st and the last one is due by November 30th. The first payment must be made by August 31st or you cannot take advantage of the payment plan!

#### SELLING A MOBILE HOME OR NON-DEEDED ISLAND PROPERTY

If you sell a mobile home or non-deeded island property you must get a "Tax Permit" (\$2.00) from the tax collector. This is to ensure that all taxes are up to date, and this is how the new taxes are transferred to the new owner!

### LONDONDERRY TOWNSHIP ILLICIT DISCHARGE AWARENESS

An illicit discharge is any discharge not composed entirely of stormwater, entering a Municipal Separate Storm Sewer System aka an "MS4" aka a storm drain.

An illicit discharge also includes any piping or drainage leading directly into a storm drain that was not initially placed during construction. MS4's are only intended to carry stormwater directly to streams and rivers. Any illicit discharges flowing into an MS4 can pollute the streams in the area, harming the wildlife and way of life of the people who use these streams.

#### How You Can Help?

The easiest way you can help is by disposing of liquid wastes properly and not allowing them to flow into storm drains. You can also check your storm drains near your home to make sure no pipes are flowing from your home which you were not previously aware of.

#### **Examples of Illicit Discharges**

- Sanitary Wastewater
- Septic Tank Effluent
- Chlorinated Pool Discharge
- Improper Oil/Radiator Flushing Disposal
- Laundry Wastewaters
- Spills from roadway accidents
- Improper disposal of household toxins

#### **Exemptions**

- Discharges from fire-fighting activities
- Fire hydrant flushing
- Potable water, including water line flushing
- Uncontaminated condensate from air conditioners, coolers, and other compressors and from the outside storage of refrigerated gases or liquids
- Irrigation drainage
- Landscape watering provided all pesticides, herbicides, and fertilizer have been applied in accordance with the approved labeling
- Pavement wash waters where no detergents are used and no spills or leaks of toxic or hazardous materials have occurred
- Routine external building washdown that does not use detergents
- Uncontaminated ground water or spring water

<u>Animal Surrender Forms</u> — Animal surrender forms are for stray cats and dogs. Forms are available at the Township office Monday - Thursday 8am - 4pm and Fridays 9am- 2pm. Before bringing the animal to the Humane Society, residents must first obtain an animal surrender form. One form per animal is given. Proof of residency is required.

### Codes/Zoning

#### **International Property Maintenance Code 2018**

The Board of Supervisors at their August 1, 2022 meeting voted to update the 2009 International Property Maintenance Code ("IPMC") with the 2018 edition of the IPMC with the adoption of Ordinance 2022-01 that may be found on the Londonderry Township web site at www.londonderrypa.org

The IPMC includes in part a variety of requirements for exterior property areas, and exterior elements of the structure by providing:

- specific criteria for regulating the installation and maintenance of building components
- maintenance requirements for the structural, weather resistance, sanitary and safety performance of the structure's exterior.
- criteria for maintaining exterior property areas.

- minimum maintenance requirements for vacant structures and land.
- criteria to determine unsafe structure conditions based on specific parameters.

The provisions of the IPMC, as modified by revisions as provided in Section 5-202, as amended, of Part 2 of Chapter 5 of the Londonderry Township Code of Ordinances, apply to all existing residential and nonresidential structures and properties within the Township, including all island properties, and constitute minimum requirements and standards for premises, structures, equipment and facilities. Copies of the IPMC booklet are on file in, and can be reviewed at the Township Building in the Office of the Code Enforcement Officer.

#### **Driveway Permits**

Most driveway repairs and/or replacements require a Driveway Repair Permit. All new driveways do require a permit before installation. If you are planning to do any repairs to your driveway, but are not sure if a permit is required, please contact the Township Public Works Department at 717-944-9440 or email <u>abrandt@londonderrypa.org</u>.

### Need A Building And/Or Zoning Permit? *Just Follow the Online Application & Payment Process*

Building and zoning permit applications and payments are now made online through the <u>BCO@londonderrypa.org</u> website, under the Building and Codes Quicklinks Section 3, "pay permit application fee and/or permit fees online".

Payments can be made online, or by check or money order made payable to Londonderry Township, by placing payment in the drop box located inside the lobby of the township building. Payments can also be mailed to Londonderry Township at 783 S. Geyers Church Road, Middletown, PA 17057. Cash is not accepted. Your permit can be picked up at the township building inside the lobby or your permit will be mailed, once confirmation of payment has been made.



### Public Works Department

#### Winter Maintenance and Snow Removal

Like it or not, it will be cold and snowy again soon. The Londonderry Township Public Works Department is ready for the winter season.

We are always looking to recruit part-time snow plow truck drivers, CDL and non-CDL drivers. If you or anyone you know is interested, please complete an application on the Township website.

When we are not performing winter maintenance on our roads, we will be doing other maintenance work on various Township roads. Please be alert for Work Area signs, equipment and Public Works employees.

The following are additional reminders for snow removal:

- Do not place snow on Township roads, in drainage ditches or over storm drains. If you have a storm drain in front of your property, please keep it clear of leaves and all debris.
- If you have a basketball net that hangs over any portion of a Township road, please remove it. It is a hazard for passing vehicles, including garbage trucks, delivery trucks and especially snow plows that need to get close to the curbing and the edge of the road.
- Residents should take the time to secure loose or broken mailboxes, fences or other property that lies within close proximity to the roadways, to prevent avoidable damage from normal snow plowing operations.
- When snow falls, please be patient. Our crews salt 67 miles and plow 135 lane miles of Township and State roads. We will do our best to get a plow truck to your street as quickly as possible.

- If you clear your driveway before the street is plowed, pushing or blowing of snow into the streets is not permissible. When the plow truck comes by, the snow will inevitably end up back on your property. It is NOT the responsibility of the Township to clear the end of your driveway once the plow has passed through.
- When a snowstorm is forecast, remove all vehicles from Township roads so the entire road can be plowed.
- Plowing main arteries will be our first priority, followed by secondary roads and then developments.
- Sidewalks and fire hydrants must be cleared within 24 hours after the end of a snow or ice event.

Please call the public works department at 717-944-9440 with any questions or concerns related to the potential roadway and/or winter maintenance.

Vehicles parked on Township roads during snow storms are not only a hindrance to properly clear the road, but also cause a hazard to the parked vehicle and/or our Township equipment.

During all snow events, please move all vehicles off the road until the snow is cleared.

If any vehicle(s) are parked in any area that will make our job difficult, your road will not get plowed until the vehicle(s) are moved off the road.

If you don't have room to park your vehicles in your own driveway, ask a neighbor who might have a space to park

#### **Rugby Club Update**

Efforts at Perseverance field continue to enable Harrisburg Rugby and other sports to utilize this facility to promote sport and fitness across generations.

We have received 700 cubic yards of topsoil that will be screened and put across the fields over the upcoming several years to promote a better playing surface with good grass growth.

Power and water has been supplied for the facility enabling the use of an irrigation system to allow for watering of the field during the summer months. The water source is from an on-site well the club had drilled, and the power is from the grid. Harrisburg Rugby Club is paying for all electric that will be consumed for the complex, whether for soon-to-be installed lights, the running of the well pump for irrigation, or for any future

additions.

The site has had 8 x 80' poles installed to allow for dedicated LED flood lights that are designed to only cover the field area. These are specially positioned and refined to not contribute to local light pollution as is typical with flood lights for other sporting events and complexes.

The development of the site has been slow but we should be playing on it in 2024!

The support of the township, the golf club, and the local residents has been pivotal to get this facility to this stage. We remain committed to get it finished and support the promotion of sports and fitness for the local community.
